

BEAVER VALLEY NUCLEAR POWER STATION TO REFUEL UNIT 2

Shippingport, PA – FirstEnergy Nuclear Operating Company (FENOC) today announced its Beaver Valley Nuclear Power Station Unit 2, located in Shippingport, PA, began a refueling outage early Monday, April 14, 2008.

While off-line, several improvement projects will take place including replacing the unit's high pressure turbine, which is expected to increase the plant's electrical output. In addition, the reactor vessel and other plant safety systems will be inspected to ensure the safe and reliable operation of Unit 2.

Beaver Valley Unit 2 operated for 520 consecutive days, the second most reliable run in the unit's 20-year history . From October 2003 to April 2005, Unit 2 established its reliability run record of 537 days. During 2007, Unit 2 had top-quartile capability factor performance (99.8 percent) and forced loss rate performance (.05 percent).

The Beaver Valley Power Station is owned by Akron, Ohio-based FirstEnergy Corp. (NYSE: FE), and is operated by FirstEnergy's FENOC subsidiary.

FirstEnergy is a diversified energy company headquartered in Akron, Ohio. Its subsidiaries and affiliates are involved in the generation, transmission and distribution of electricity, as well as energy management and other energy-related services. Its seven electric utility operating companies comprise the nation's fifth largest investor-owned electric system based on serving 4.5 million customers in Ohio, Pennsylvania and New Jersey; and its generation subsidiaries control more than 14,000 megawatts of capacity.
